

## Clovis Swim Club & Fig Garden Masters SCY Meet

November 8, 2008

### Clovis North Aquatics Complex (Clovis North High School)

Sanctioned by Pacific Masters Swimming Inc. for USMS Inc. Sanction Number: 38-08-22

- Date/Time:** Saturday, November 8, 2008 – 1:00 PM
- Location:** Clovis North High School. Highway 41 or 99 to Herndon Avenue, east on Herndon to Willow, north on Willow to the corner of Willow & International. Continue on Willow to the east end of the campus and turn left at the tennis courts. Drop off at the pool entrance and continue to Chestnut (left) and left into the parking lot.
- Facilities:** Two 50 M x 25 Yard outdoor pools. The competition pool is all deep with a minimum depth of 7 ft. and offers two 8 lane courses for SCY competition. The adjacent multi-purpose pool has 18 lanes in SCY. Both are heated and cooled to maintain a constant temperature. Colorado timing and scoreboard will be used. Locker room and showers are available. A concession stand will be available.
- Schedule:** Warm-up will begin at 11:30 AM with the meet starting at 1:00 PM
- Check-in:** The meet will be deck seeded using a master check in system. Positive check-in is required for all events. Swimmers in the first two individual events must be checked in by 12:30 PM. Swimmers in later events must check in at least 30 minutes prior to the estimated start of their event. There will be no printed program only posted events.
- Entries:** Online entries: Enter at <http://clov.mastersswim.com> by **midnight Wednesday, November 5<sup>th</sup>**. (Swim Connection charges an internet processing fee of \$1 per swimmer plus 5% of the total entry fee). This is a cardless meet. Non-electronic entries must use the consolidated entry form found in the Pacific Masters Swimming newsletter or from the Pacific Masters web site ([www.pacificmasters.org](http://www.pacificmasters.org)). Please submit short course yards times for proper seeding. Swimmers may enter up to 5 individual events and both relays. **All events may be deck-entered on the day of the meet.** Deck entries will be accepted until 12:30 PM. Swimmers will be seeded according to submitted times.
- Entry fees:** \$4.00 per individual event plus a surcharge of \$5.00 per swimmer for preregistered entries, and a \$10.00 per swimmer surcharge for late or deck entries. All relays may be deck-entered at a cost of \$4.00 per relay. There are no refunds.
- Deadline:** **Preregistered entries must be postmarked by Wednesday, October 29, 2008, or received by Saturday, November 1, 2008. Mail the consolidated entry form, check, and a copy of your 2008 USMS registration card. Make checks payable to: Clovis Swim Club. Online entries are due by midnight Wednesday, November 5<sup>th</sup>.**

- Awards:** Ribbons 1<sup>st</sup> through 8<sup>th</sup> in each age group.
- Conduct:** All events will be seeded and swum slow to fast. Both the 400 Y and 200 Y Freestyle Relays will be offered in Men's, Women's and Mixed genders (2 men and 2 women in any order). Each swimmer may participate in only one 400 Y and one 200 Y Freestyle relay. Depending on the number of entries, the meet will be run on an 8 or 10-lane course or 2 x 8-lane courses to maintain a projected time line of approximately 4 hours. There will be 8 lanes available for continuous warm up and warm down.
