### <u>Communications and Technology report – Michael Moore</u>

Worked with the coaches committee creating coaches registration survey.

After the PacMasters SCM championships we surveyed all the swimmers. Almost 50% of the swimmers responded, which is a very high sample rate. Information identifying a particular swimmer was removed and the results were sent to the meet director.

Last meeting we spoke about how swimmers get their results. In the survey participants said they got results:
